

# SECOND RESTATED AND AMENDED ARTICLES OF ASSOCIATION OF DOWNTOWN BOISE NEIGHBORHOOD ASSOCIATION

October 22, 2009  
JULY 8, 2015

This Second Restated and Amended Articles of Association of the Downtown Boise Neighborhood Association is made effective the 8<sup>th</sup> day of July, 2015 to restate and amend the First Articles of Incorporation dated October 22, 2009.

## ARTICLE I NAME

The name of the association shall be "Downtown Boise Neighborhood Association," (hereinafter, the "Association").

## ARTICLE II OFFICE

The principle office of the Association shall be the mailing address of the President of the Association.

## ARTICLE III PURPOSES

The Association is organized and will be operated to: A) provide an open process by which all members of the association may involve themselves in the affairs of the neighborhood; and B) identify the physical and social needs of the neighborhood; and C) identify ways to meet those needs, including seeking funding sources and programs; and D) educate members about issues affecting neighborhoods; and E) engage the neighborhood in the planning and development process; and F) provide an opportunity for the people of the neighborhood to participate in the decision-making processes of the agencies that impact neighborhoods.

## ARTICLE IV STRUCTURAL ORGANIZATION

This Association shall be composed of a Board of Directors and its officers, and a general membership as specified in the Bylaws of the Association. Voting rights and procedures are to be as specified in the Bylaws of the Association.

## ARTICLE V POWERS

The authority of the Association is vested in the members as prescribed in the Bylaws of this Association. The Association is empowered to: A) collect and disseminate information; B) conduct public meetings; C) engage in funding and fund-raising activities; and D) promote the purposes of the Association.

ARTICLE VI  
BOARD OF DIRECTORS

The affairs of the Association shall be managed by the Board of Directors. The Directors shall be elected in the manner and for the terms as provided by the Bylaws of the Association. The names and addresses of the persons who are to act in the capacity of Directors until the selection of their successors are:




ARTICLE VII
